# From the British High Commission: The East Africa Trade and Investment Forum

On 21-22 May, the UK Government in partnership with DMA Invest, hosted the inaugural East Africa Trade and Investment Forum (EATIF) in London. We were delighted to host a senior delegation of Ugandan Ministers and officials for the event, including the Honourable Francis Mwebesa, Minister for Trade, Industry and Cooperatives, and Honourable General Wamala, Minister for Works and Transport. The UK's Minister for Africa, Lord Collins, delivered a keynote speech, as did the Prime Minister's Trade Envoy for East Africa, Kate Osamor MP. We were also delighted that a number of our BCCU members were in attendance, and wanted to say a huge thank you to Nexus Green for taking part in one of the panel sessions, representing the BCCU and for being an excellent ambassador for Uganda as an investment destination.

It was a vibrant and popular event with more than 500 British, Ugandan, Kenyan and Tanzanian businesses and other stakeholders in attendance across the two days. We worked hard to promote Uganda as an investment destination, to highlight the favourable business environment, and Uganda's strategic regional location, and role as a gateway to the East African market. The event provided an excellent opportunity to meet with important new and existing stakeholders and make new connections with the private sector across the region. The major focus for Uganda was the ten-fold growth strategy and how British companies can contribute to it by tapping into various opportunities presented in the areas of Agriculture, Tourism, Mineral Development and Science & Technology (ATMS).

- Uganda's 10X Strategy is a bold and actionable roadmap that positions the country as a high-potential investment destination across the ATMS sectors.
- Standard Chartered is uniquely positioned to leverage its cross-border capabilities to facilitate investment, mobilise global capital and deliver solutions that align with Uganda's long-term development agenda.
- Public-private collaboration emerged as a central driver for unlocking sustainable and inclusive growth, with strong commitment from both Ugandan leadership and global stakeholders.
- Investor confidence in Uganda was reinforced through compelling reforms, a stable macroeconomic environment, and a clear commitment to creating a conducive investment climate.




